RE: Amendment to Geographic Name Report: Silvan Ridge

This letter is to correct and clarify information on our current Geographic Name Report that has been recommended by Lane County to name a ridge that we are located on "Silvan Ridge." The following are corrections to the current text:

- Under Name Information, the ridge has not been called Silvan Ridge for several decades, but rather locals assumed that Silvan Ridge was the name of the ridge we are located on since around 1993, when the Silvan Ridge name was introduced to the public.
- Approximate # of years that Silvan Ridge was thought to be the name of our location: 20-23 years

One further clarification pertains to the name "Silvan" being commemorative or not. Our application and name proposal is about naming a wooded ridge "Silvan" and is not commemorative. We are not, in essence, naming the ridge after ourselves. Our brand name has ties to Carolyn Chambers, as Silva was her maiden name, but for us, there is a clear distinction between naming the ridge we are on the side of "Silvan" because of the Latin meaning for Silvan, and our actual brand story.











WHEREAS, geographic naming in Oregon is a public process by which anyone can submit a formal proposal for consideration; and,

WHEREAS, the Oregon Geographic Names Board (OGNB) is the official advisor and state geographic names authority of Oregon; and,

WHEREAS, the purpose of the OGNB is to supervise the naming of geographic features within the state of Oregon and to make recommendations to the United States Board on Geographic Names (USBGN), which has final approval authority; and,

WHEREAS, the OGNB has received a formal proposal from Ms. Angela Bennett to name a Lane County ridge that is located above the Silvan Ridge Winery "Silvan Ridge". This ridge has been called Silvan Ridge informally by local residents for several decades; and,


WHEREAS, the OGNB has determined that the creek has not been previously named and current property owners do not object to the proposed name; and,

WHEREAS, the OGNB requires the written option of the Lane County Commissioner on this matter prior to the OGNB forwarding a recommendation to the USBGN.

NOW, THEREFORE, the Lane County Board of Commissioners **ORDERS AND RESOLVES** as follows:

1. Full support for the proposed name of Silvan Ridge, attributed to the north-south bearing ridge that is centered at 43° 57' 12"N, 123° 15' 41" W and runs across private lands owned by Mr. Darrel Spiesschaert and Ms. Jeanette Kessler, both of whom have submitted their interest in this matter to the OGNB.


